NOTE:

A refund of entry fees (less \$10.00 handling fee per day) for bitches entered in agility that come in season after the closing date of this trial may be obtained by presenting a veterinarian certificate to the Show Secretary. The certificate must be postmarked before the opening day of the show or given to the Show Secretary one-half hour prior to the start of the show.

Withdrawal due to injury or illness after the closing date is eligible for a 50% voucher for entry at future MHGRC events provided a veterinarian's letter attesting to the nature of the injury is provided within one week of the show. In such instances the secretary MUST be notified by letter or e-mail, no later than 24 hours before the start of the show. False reports warrant refusal of entries at future MHGRC events.. Any other withdrawals after the closing date will not be eligible for refund.

Move-ups in Agility will be allowed at this trial.

Go to the LabTestedOnline.com home page and follow the instructions to enter these trials on line. During the first 48 hours after opening, the initial limit of entries designated as either online or paper will be as follows: 30 online entries and 70 paper entries each day. If either form of entry (paper or online) has not filled at the end of the 48 hour time period, the club reserves the right to decrease or increase either one accordingly.

Exhibitors who include a legible email address on the entry form will receive an email confirmation of entry received. Please contact the show secretary if you do not receive a confirmation of entry received within a reasonable time. **The show grounds will be available to exhibitors at 7:00am**

MEASURING and HEIGHT CARD INFORMATION

COVID NOTICE: *Measuring of Dogs: As of March 1, if a VMO or Agility Field Representative is measuring dogs at a trial, all present and entered dogs without a valid measurement must be measured. Until further notice, Judges of Record who are not VMOs will still not measure dogs. Thank you for the continued hard work and creativity you all continue to share with our sport.*

All agility dogs are required to have an Official Jump Height Card and exhibitors must be able to present it prior to running their dog(s) in any class or at any time during the trial upon request. Dogs without a valid Jump Height Card may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for this trial or back-to-back trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog **before** its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

All measurements are effective immediately.

Exception: Challenge measurements to Permanent Jump Height become effective when Challenge Measurement Process is complete (see Regulations).

Dogs entered in Preferred Classes must run in measured Height Division - must be moved up or down to proper height.

OBSTACLES

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials

COURSE FAMILIARIZATION, TIMING AND WARM UP

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog. Umbrellas are not allowed on the course during the walk thru. Electronic timing devices may be used.

Armband stickers will not be used at these events.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs 15 months of age and older that are registered with the American Kennel Club or are registerable breeds that have obtained an AKC ILP/PAL number or an AKC Canine Partners listing number. Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. **Puppies under four months of age are strictly prohibited from the trial grounds.**

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word 'dog' is used in these regulations it includes both sexes. Canine Partners are allowed entry into this set of trials.

MOVE UPS and CLASS CHANGES

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Friday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded. Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.

Effective February 1, 2017

Regulations for Agility Trials: Chapter 1, Section 21. Change of Entry. In addition to Move-ups as described in Chapter 1, Section 20 entries may also be changed as noted in this section. A dog which has been entered in a Novice "A" class for which it is not eligible to be entered in due to class restrictions on the dog or handler may be moved to the Novice "B" class under the following conditions: The request for the move must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial. The request must state the reason and justification for the move from a Novice "A" class to the Novice "B" class. After the close of entries a dog may be moved down in their class level (i.e., Master to Excellent). The request for the move to the class for which the dog is eligible must be in writing and submitted to the superintendent or trial secretary at least 30 minutes prior to the start of the trial.

If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. For example, the same dog may now be entered in Regular FAST and/or T2B to finish up those titles while also entered in Preferred Master STD/JWW to start working towards their PACH at the lower height. Any mixture of Regular and Preferred classes is allowed.

Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

When calculating entry fees, treat multiple entry forms for the same dog as if only one form had been filled out. In other words, the 1st run entry fee is only paid once per day, per dog, even if that dog's runs have been submitted on multiple entry forms.

NOTICE TO EXHIBITORS

A required \$1.50 fee per dog is collected by MHGRC for Island Grove Regional Park. These fees are used for park improvements.

At every Licensed or Member Club Agility Trial a recording fee of \$3.50 shall be required for the first entry of each dog, \$3.00 for each additional entry of the same dog. These AKC fees are to be collected by the show giving club and paid to the American Kennel Club. Ch. 1, Section 24, AKC Regulations for Agility Trials.

No entry may be sent by any method that requires a signature for delivery.

A judging schedule will be emailed to each entrant as soon as practical after the closing of entries.

Make checks payable to MHGRC, US Funds only. Telephone and FAX entries will not be accepted. Canadian Exhibitors must submit entries with checks drawn on U.S. accounts or with an international money order in U.S. funds. On-line entries available through www.akc.org.

Entry Fee will not be refunded in the event a dog is absent, disqualified, excused by veterinarian or judge, or barred from competition by action of the Show Committee.

Exhibitors are responsible for complete, accurate, legible information on their entry forms. Post dated and returned checks to not constitute a valid entry. A returned check will be assessed a \$25.00 service fee. Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.

Exhibitors are responsible for calculating entry fees; refunds due to exhibitor error are at the option of the club. There are no refunds for duplicate entries. The secretary will make an effort to find duplicate entries, but if an entry has been processed, no refund will be made.

Changes, additions, or corrections to entry forms must be received prior to the close of entries. Those received by telephone will not be accepted.

Entries must be made on an official AKC entry form, or photocopy of the official entry form with the Agreement and Rules on the reverse side, or they cannot be accepted.

The owner or agent assumes all responsibility for wrong or incomplete information in the entry form.

No entry fees will be refunded if the show can not open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strike, and/or any other causes beyond the control of the Mile Hi Golden Retriever Club or Show Secretary.

No entry will be accepted which specifies any condition as to its acceptance. Entries will not be accepted with out signatures, fees and the Agreement Page. Mile Hi Golden Retriever Club may decline any entry for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause, and no one shall have any claim or recourse against the clubs or any official there of.

Dogs need be present only for scheduled judging and will be released if not needed for further judging. Dogs must be ready for judging. Neither the Club nor Event Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of breed or class judging. Judges need not wait for any dog. Owners or agents alone are responsible for the presence of their dogs in the ring.

The show and trial grounds at this show constitute the rings and adjacent areas, grooming and crating areas and parking areas.

Tenting areas are under the supervision of the Grounds Committee who may require rearrangement of an exhibitor set up where space is not properly utilized. **No generators are allowed; there is ample electricity.** Exhibitors are responsible for the conditions in and around their crating areas.

Dogs may not be tied to bushes, shrubs, trees or other permanent fixtures. No dogs in the restrooms. Unentered dogs may be asked to leave the show/trial grounds. Puppies 4 months of age are allowed at AKC Agility Trials..

Mile Hi Golden Retriever Club (MHGRC) and Greeley KC, their agents, employees, etc., assume no responsibility for any loss, damage or injury, sustained by exhibitors, handlers, or their dogs, or property, and further assume no responsibility for injury to guests and/or children.

All vehicles are parked at owner's risk. Island Grove Park and the show giving club will not be responsible for loss by fire, burglary, theft, or any other cause whatsoever to the vehicle or its contents. Exhibitors are responsible for cleaning up after their dogs at all times.

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have proper vaccinations.

CITY OF GREELEY ORDINANCE - DOGS ARE NOT ALLOWED IN ANY CITY PARK EXCEPT ISLAND GROVE REGIONAL PARK.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes.

Safety of the dogs is our primary concern. By entering this agility trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with, and are able to perform, all of the obstacles safely.

All dogs must be on leash at all times except when in the ring or in the designated warm-up area. It is expressly understood that the exhibitors alone are responsible for the behavior of their dog(s), guest(s), and children. Any exhibitor whose dog(s), guest(s), and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the trial. In such case, no refund of fees paid will be made.

All prizes and trophies must be claimed the day of the show. None will be mailed unless otherwise noted in the premium. The club reserves the right to substitute a prize of equal or greater value.

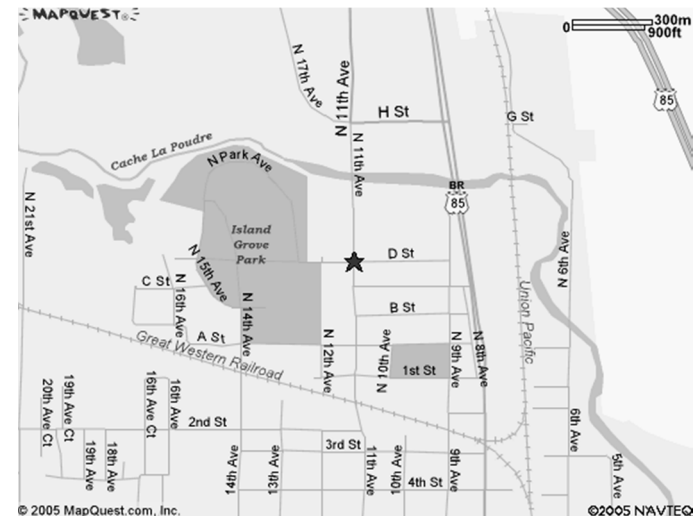
